## **Contract on Using Express Services for 1 Storage Year**

No.: Budapest Court as Court of Registration, Cg. 01-10-045043 hereinafter referred to as MFGT or jointly referred to as the Parties at the undersigned place and date under the following terms and conditions: **PREAMBLE** On \_\_\_\_\_\_ 202\_, MFGT published an announcement notice on its website (www.mfgt.hu) on "Using Express Services" publicly available under the same conditions to any System User that is subject to Act No. XL of 2008 on natural gas supply (Gas Act) and the related Government Decree No. 19/2009 (I.30.) on the implementation of Act No. XL of 2008 on natural gas supply (Implementation Decree)

Under the conditions specified in the announcement notice, System Users subject exclusively to the Gas Act and the Implementation Decree become eligible for concluding the contract on *Express* 

exclusively.

Services if they have working gas capacity booking and the relating injection capacity and withdrawal capacity (hereinafter Capacity Booking Contract) of at least 1 000 000 kWh for the storage year 2021/2022 until the conclusion of this contract.

Having taken ... kWh working gas capacity booking and the related injection, withdrawal capacity booking (working gas, withdrawal and injection capacity bookings hereinafter jointly referred to as Capacity Booking) on ..... 202\_, System User meets the conditions of requesting services (services and fees jointly: "Express Services") listed in Annex No. 1, hence Parties conclude the following contract.

Upon paying HUF 84 400 +VAT service fee (Service Fee), System Users meeting the announcement conditions shall be entitled to a budget limit (hereinafter Budget Limit) of HUF ...... + VAT for each 1 000 000 kWh working gas capacity booking from the Capacity Booking, which budget limit can be spent on using Express Services.

## I SUBJECT AND DURATION OF CONTRACT

- 1. Subject of the Contract on Using Express Services (hereinafter referred to as Contract):
  - a) upon paying the fee specified in Section V.1, for ....... kWh working gas capacity booked from the Capacity Booking, System User shall be entitled to a Budget Limit of HUF...... + VAT, that is ...... Hungarian forints + VAT to be used for Express Services.
  - b) System User can use the *Express Services* provided by MFGT as per Annex No. 1 under the conditions set forth herein, during the storage year 2021/2022, until the Budget Limit specified in the above item "a" is spent.
  - c) method of using Express Services:
    - i. System User declares what kind of quantity it intends to use from which Express Service
    - ii. if the capacity amount requested by the System User is available from the Express Service specified by the System User, Parties conclude a contract on the specified Express Service on the basis of this contract and under the conditions set forth by the contract on the specified Express Service and by the ÁSZF (e.g.: nomination, allocation etc.).
      - In the event of capacity congestion, MFGT shall satisfy earlier bookings up to the extent of the available capacity quantity.
    - iii. methods of using further quantities:
      - in case of booking a further amount of at least 1 000 000 kWh working gas capacity and related injection capacity and withdrawal capacity, under conditions identical to those specified herein, by concluding a new Express Contract

- 2. This Contract shall be concluded for a definite period until 01 April 2022 at 06:00 hours. System User shall be entitled to spend up to 50% of the Budget Limit unless the Budget Limit has already been spent in the storage year 2021/2022 as specified in Section III.3.
- 3. Parties shall contract for using and providing Express Services specified in Annex No. 1 for the fees set out in Annex No. 1. The contractual injection cycle shall start at 06:00 on 01 April 2021, and shall end at 06:00 01 October 2021. The contractual withdrawal cycle shall start at 06:00 on 01 October 2021 and shall end at 06:00 01 April 2022. Regarding Express Services, Storage Plus Optional Service and/or Daily Peak Plus Optional Service and/or Intraday Nomination Plus Optional Service can also be used in this period.
- 4. The detailed conditions of using Express Services shall be specified in the contract template on storage capacity booking concluded upon application and in the ÁSZF. (Template contracts and the ÁSZF can be accessed on the MFGT website.)
- 5. Express Services used under this contract cannot be subject to secondary trading.
- 6. Rights and/or obligations arising from this contract cannot be assigned or transferred unless a prior written consent is granted by MFGT.

#### II. GENERAL TERMS

- In issues not regulated by this Contract, the provisions of the template contracts relating to the services (Express Services) used under this contract and the provisions of the General Terms and Conditions (hereinafter referred to as ÁSZF), Annex No. 4 of the Code of Business Conduct shall apply.
- 2. By signing this Contract, System User shall acknowledge to have fully read and understood the content of ÁSZF herein mentioned as available on the MFGT web page (<a href="www.magyarfoldgaztarolo.hu">www.magyarfoldgaztarolo.hu</a>) and considers it to be the part of the Contract, and so agrees to be bound by it. Parties shall deem the content of ÁSZF annexed to the Code of Business Conduct approved by the Hungarian Energy and Public Utility Regulatory Authority (hereinafter: HEPURA) to be the same as the usual contracting practice.
- 3. Special conditions not stipulated in the ÁSZF shall be specified in this Contract.

#### III BUDGET LIMIT AVAILABE TO THE SYSTEM USER

- 1. The Budget Limit specified in Section I.1.a) shall be available to the System User to use Express Services. System User can use the Budget Limit pursuant to the conditions herein depending on the available capacities at its own discretion.
- 2. In the event that System User does not spend 50% of the Budget Limit during the storage year 2021/2022, the difference between 50% of the Budget Limit and the Budget spent cannot be used after storage year 2021/2022, will not be refunded by MFGT, and therefore shall be settled as "Take or Pay" TOP obligation.
- 3. System User shall be entitled to spend up to 50% of the Budget Limit if not already spent in the storage year 2021/2022, for the fee announced in the prevailing Code of Business Conduct as per Section VI for the storage service offered by MFGT. The Budget Limit unspent until the end of the storage year 2021/2022 cannot be used after the storage year 2021/2022.

4. MFGT cannot be obliged to provide any Express Service if the Budget Limit currently available to the System User fails to cover the fee of the requested quantity.

#### IV. FLOW OF INFORMATION

- 1. MFGT shall send a statement to the System User on the Express Services used in the relevant month, on the sum of services purchased against it and on the current balance of the Budget Limit, each month, for the last day of the calendar month as the reporting date.
- 2. Following the storage year 2021/2022, MFGT shall inform the System User using a balance statement format with regard to the extent of the unspent Budget Limit for the reporting date of 31.03.2022.
- 3. Parties ensure that besides the regular contacts specified in this Contract, they shall notify each other of all incidents which may have an effect on their cooperation, and facilitate smooth communication via consultation opportunities and proper dataflow.
- 4. Information and data flow between the Parties shall be governed by the Grid Code and the ÁSZF.

## V SERVICE FEE, PAYMENT METHOD, MONTHLY SETTLEMENT

- 1. The Budget Limit fee specified in I.1.a) that is the Service Fee payable for using Express Services shall be: HUF ...... + VAT.
- 2. The Service Fee for storage year 2021/2022 shall be payable until 31 March 2021.
- 3. Upon the conclusion of the "Express Service" contract, MFGT issues a periodic settlement invoice for the period until the end of the storage period.
- 4. Throughout the duration of the contract, MFGT shall issue an accounting document on the actual monthly service use, thus specifying the still available budget limit pursuant to Section IV.1 and IV.2 herein.
- 5. In case of using Daily Peak Plus and Storage Plus and Intraday Nomination Plus services, the consideration for such services shall be deducted from the System User's Budget Limit until it is spent in full. System User shall be entitled to use the Express Services pursuant to Annex No. 1 up to the Budget Limit.
- 6. MFGT undertakes that except for the "Only Working Gas" service, the scope of the Express Services and the unit prices included shall not be modified during the term of this contract.
- 7. The unit price (HUF/kWh/year) of the "Only Working Gas" service shall be revised in case of each storage tariff change. If with regard to the subsequent period even within the storage year the regulated unit price as per the tariff formula for the storage product calculated with injection and withdrawal capacities pursuant to the Capacity Booking Contract decreases below the capacity fee (HUF/kWh/year) as per the Capacity Booking Contract, the unit price (HUF/kWh/year) of the "Only Working Gas" service shall be increased by the nominal difference between the contractual capacity fee (HUF/kWh/year) and the capacity fee calculated using the tariff formula after the tariff change.

MFGT shall issue a document to be treated as an invoice regarding the Service Fee payable in relation to the Budget Limit as per Section V.1, for the remaining months of the contractual period, based on the following calculation:

"Only Working Gas" service quantity (kWh) \* (contractual capacity fee (HUF/kWh/year) - capacity fee calculated using the tariff formula after the tariff change (HUF/kWh/year))/12\*number of remaining months

The written notification on the increase of the Service Fee above and the document to be treated as an invoice shall be sent by MFGT to the System User within 5 business days from the public announcement of the tariff change.

The Service Fee shall be payable in one instalment within 15 calendar days from issuing the invoice.

#### VI SETTLEMENT OF BUDGET LIMIT REMAINING AT STORAGE YEAR END

In case of not using 50% of the Budget Limit (Section III.3), Parties shall settle with each other according to the following:

- 1. At the beginning of April 2022, MFGT shall send by email to the System User's contact person as per Section IV.2 herein a balance statement on the HUF value of the Budget Limit unused at the end of the gas day 31 March 2022.
- 2. If based on the balance statement it can be established that at least 50% of the total Budget Limit is not used until the end of the gas day of 31 March 2022, Section III.2 herein shall take effect in relation to the difference between 50% of the Budget Limit and the Budget Limit used.
- 3. Concerning maximum 50% of the Budget Limit not affected by TOP as per Section III.2 herein, MFGT shall proceed according to the following:
  - a) At the beginning of April 2022, it issues a credit invoice on the Budget Limit unused at the end of the gas day 31 March 2022.
  - b) Following this, it consolidates the unused Budget Limit with the first debit invoice issued to the System User, and thereafter keeps record of the difference only, as a receivable amount in relation to this first debit invoice.

The amount resulting from the consolidation of the unused Budget Limit and the first debit invoice issued to the System User may only be used for the following services:

- i. for the capacity fee regarding the universal service provision booked by the System User, or
- ii. for the capacity fee regarding the non-universal service provision booked by the System User, or
- iii. for volume fee type items resulting from the gas turnover relating to the two above types of bookings, or
- iv. for any other service offered in the Fee List by MFGT for the period affected by the relevant contract, at the service fee specified in the Fee List.

c) If the unused Budget Limit specified above cannot be fully credited from the first debit invoice, in case of the subsequent monthly debit invoice or debit invoices, the same procedure shall continue until the unused Budget Limit to be credited is used or until the end of the storage year 2022/2023 comes to an end and the unused budget limit is settled as TOP as per Section III.3 herein.

## VII GOVERNING LAW, SETTLEMENT OF DISPUTES

The provisions of Hungarian law shall apply to both the contract and any arising disputes.

Parties shall agree to settle the disputes between each other in relation to the Natural Gas Storage Contract primarily via amicable negotiation.

Failing such settlement in any dispute arising from or relating to the Natural Gas Storage Contract or its breach, termination, validity or interpretation, both parties hereby agree to subject themselves to the exclusive jurisdiction of the Arbitration Court in the Energy (Budapest), provided that the Court of Arbitration proceeds according to its own Rules of Procedure. The number of arbitrators shall be three. The language of procedure shall be Hungarian.

## VII ENTRY INTO FORCE

This contract enters into force on condition that the Service Fee is credited to MFGT's bank account.
